If a requestor is ineligible for the discount, GCDC shall inform the requestor specifically of the reason for ineligibility in GCDC's written response. An individual is ineligible for this fee reduction if ANY of the following apply: (i) The individual has previously received discounted copies of public records from GCDC twice during that calendar year, OR (ii) The individual requests the information in conjunction with outside parties who are offering or providing payment or other remuneration to the individual to make the request.
